**Subject: Submittal of the TCAG Administrative Modification Amendment No. 7 to the 2009 FTIP**

Dear Mr. Aljabiry:

Enclosed for your review and approval is TCAG's Administrative Modification Amendment No. 7 to the 2009 Federal Transportation Improvement Program (FTIP). Amendment No. 7 to the 2009 FTIP modifies two currently programmed projects by changing the fund source from local to the American Recovery and Reinvestment Act (ARRA) funds and is considered a TYPE I Administrative Modification (Amendment) to the 2009 FTIP.

Amendment No. 7 modifies TUL06-151 "Ben Maddox Way Bridge" by replacing \$6,300,000 of local funding (\$3,500,000 City of Visalia, \$2,800,000 Local Measure R) with ARRA-STP and programming an additional \$1 million (less then 20%) with ARRA-STP (\$100,000) and Local-City (\$900,000).

Amendment No. 7 modifies TUL00-103 "Widen Road 108" by switching \$7,222,000 from local funding (\$7,222,000 Measure R) with the currently programmed ARRA -STP (\$2,056,000) and ARRA-RSTP(\$5,164,000) funding source.

The funding is being programmed in the financial Plan of the 2009 FTIP under ARRA-STP and ARRA-RSTP as requested by TCAG Board. These two currently programmed projects are included in the Conformity Analysis for the 2009 Interim FTIP and 2007 RTP Amendment No. 1 and no further conformity determination is required. This amendment does not interfere with the timely implementation of any approved Transportation Control Measures (TCMs).

Amendment No. 7 to the 2009 FTIP meets all applicable transportation planning requirements per 23 CFR Part 450 and 40 CFR Part 93. It is requested that both the State and Federal approval process be expedited to the extent possible to allow programming the

Federal approval process be expedited to the extent possible to allow programming the ARRA funds.
